Banding/Affiliation Agreement

This Agreement is done to memorialize the Banding and Affiliation of the Cherokee Indians of Robeson and Adjoining Counties (CIRC) and all affiliated Native American Bands/Tribes & Indigenous Entities aligned with CIRC, including Three Rivers Tribal Organization (3RUN) (a UN Recognized Entity) and American Indian Mothers, with the United Cherokee Nation of Indians – Aniyvwiya; which further provides as follows:

- 1) For alignment in order to avail the Tribal Organizations and Entities of the benefits that can be derived from programming under IRC 7871 pursuant to a Hoopa Valley tribal entity,
  - 2) For furthering opportunities of Economic Development with and between said Tribal Entities which can mean:
- A) Development of opportunities that expand Tribal Healthcare programs or Urban Indian Programs in ways that meet or exceed the provisions mandated in the Affordable Care Act (ACA) and which provide the Exemptions as authorized therein for the Tribal Members or those authorized by the Tribal groups to receive these benefits,
- B) Developing organic agricultural programs and opportunities in order to provide good quality, nutritional foods for the Tribal Members or those authorized by the Tribal groups to receive these benefits,
- C) Developing safe drinking water programs for the Tribal Members or those authorized by the Tribal groups to receive these benefits and
- D) Developing all other programs that can be fostered and advanced to increase Economic Development for all, which would include taking advantage of the Small Business Administration - 8(a) Program, Native American Housing Assisting and Self-Determination Act (NAHASDA) opportunities, as well as other state or federal programs that may be applicable.
